Data Collection Definitions

*Definitions updated 12/10/2025*

**Data Abstraction Instructions:** For each medication, record whether it was administered or contraindicated during the specified timeframes.

**Selections:**

- **Contraindicated:** history of allergy, reaction, sensitivity, or intolerance to the medication as documented in the patient's medical record.
- **During:** Medication was administered while the patient was physically in the procedure room.
- **Given:** Medication was administered (use when timeframe is unspecified).
- **Medications at Admission:** medications the patient was taking before the current ASC/non-hospital outpatient visit.
- **Medications at Discharge:** Medications the patient was prescribed or instructed to resume at discharge.
- **Not Given:** Medication was not administered.
- **Post:** Medication was administered after the patient left the procedure room, up to discharge or the next procedure (whichever occurs first).
- **Within 24 hours:** Medication was administered within 24 hours before PCI procedure start and/or during the PCI procedure.

### Combination Therapy

**Data Abstraction Instructions:**

For combination drugs, record each individual component unless a specific combination option is available to select.

**Examples:**

- If the patient receives **Zestoretic** (lisinopril + hydrochlorothiazide), record as both **ACE inhibitor** and **diuretic**.
- If the patient receives **Entresto** (sacubitril + valsartan), select "**Entresto**" since it is a specific option.

*Note: Medication lists provided are not all-inclusive.*

### Aldosterone Antagonist

**Data Abstraction Instructions:**

At discharge, indicate if an aldosterone antagonist was prescribed or not prescribed.

**Selections:**

- Prescribed
- Not Prescribed

### Aspirin

Data abstraction instructions: Record if Given, Not Given

**Selections:**

At discharge:

- Given

### Supporting Definitions

To code "yes" for aspirin, the minimum dose should be at least 75mg.

### Bempedoic Acid

#### Data Abstraction Instructions:

For Bempedoic acid (including combination drugs), select whether it was prescribed or given.

### Bivalirudin

#### Data Abstraction Instructions:

Record if bivalirudin was administered.

- Post (administered after leaving the procedure room, up to discharge or next procedure)

- **Not Given**

### Cangrelor

#### Data Abstraction Instructions:

Record if Cangrelor was administered.

#### Selections:

If "Given," select all timeframes that apply:

### Colchicine

#### Data Abstraction Instructions:

Record whether colchicine (or colchicine/probenecid) was prescribed or given.

#### Selections:

- Prescribed
- Not Prescribed
- Given
- Not Given

## Entresto

### Data Abstraction Instructions:

Record if Entresto (sacubitril and valsartan combination) was prescribed at discharge.

*Do not capture other medications containing angiotensin II receptor blockers. Only record the specific combination of sacubitril and valsartan (Entresto).*

## Eptifibatide (Integrilin)

### Data Abstraction Instructions:

Record if eptifibatide was administered during PCI procedures only.

  - Post (administered after leaving the procedure room, up to discharge or next procedure)
- **Not Given**

## GLP-1 Agonist

### Data Abstraction Instructions:

Record if a GLP-1 agonist was prescribed at admission.

### Selections (At Admission):

- Prescribed
- Not Prescribed

## Hydration

### Data Abstraction Instructions:

Record whether hydration (oral or intravenous) was given or not, and document the volume administered (in mL/cc). Specify the timing as outlined below.

### Oral (PO) Hydration:

- **Post:** Record any fluid intake consumed by the patient within **6 hours after** procedure completion.

### Selections:

- **Given**

- 6hr post: Enter volume in mL or select "N/A" if not documented.

- **Not Given**

**Intravenous (IV) Hydration:**

- **During:** Record the same IV infusion types administered **during** the procedure.
- **Post:** Record these IV fluids administered **within 6 hours after** procedure end.

**Selections:**

- Given
  - During: Enter volume in mL or select "N/A" if not documented.
  - 6hr post: Enter volume in mL or select "N/A" if not documented.
- Not Given

**Range:**

1- 15,000 mL

**IV Vasopressors**

**Data Abstraction Instructions:**

Record if IV vasopressor infusions (not bolus doses) were administered during PCI.

**Selections:**

- Given
 

If "Given," select all agents that apply:

  - Dopamine
  - Norepinephrine
  - Phenylephrine
  - Other (specify)

- Not Given

**Supporting Definitions:**

Agents include:

- Norepinephrine
- Epinephrine
- Dopamine
- Phenylephrine
- Vasopressin
- Dobutamine
- Giapreza (angiotensin II)

**Icosapent Ethyl**

**Data Abstraction Instructions:**

Record if Icosapent ethyl was prescribed at discharge.

**Selections (At Discharge):**

- Prescribed
- Not Prescribed

**Supporting Definitions:**

**PPI (Proton Pump Inhibitor)**

**Data Abstraction Instructions:**

Record if a proton pump inhibitor (PPI) was prescribed.

**Selections:**

- Prescribed

### Data Abstraction Instructions:

Record if a statin was given, not given, or contraindicated.

### Selections:

- Given
